# Q1. How many patients have been treated (for any condition) in the last 4 months with:

- Benralizumab 29
- Omalizumab 47
- Reslizumab 0
- Mepolizumab 26

# Q2. Of the patients treated in the last 4 months with any of the above products, please provide the number of patients by the following age-groups:

- Age 6-11 \*
- Age 12-17 8
- Age 18 and above 93

Please note: Where the figures are between 1 and 5, this has been denoted by \*. Due to the low numbers, we have considered that there is the potential for individuals to be identified from the information provided, when considered with other information that may also be in the public domain. In our view disclosure of these low figures would breach one of the Data Protection Principles set out in Schedule 1 of the Data Protection Act, namely Principle 1.
