Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

When was your last networking (LAN, Core, edge) refresh, and when is the next refresh planned?

This is ongoing.

When was your last Wi-Fi refresh, and when is the next refresh planned?

This is ongoing.

When was your last telephony or Unified Communications refresh, and when is the next refresh planned?

September 2022. There are no plans for replacement as yet.

When was your last mobile devices/pagers refresh, and when is the next refresh planned?

The replacement of mobiles is ongoing so takes place most weeks. There is an ongoing replacement programme each year.

Can you confirm contract end dates and vendors for the above?

CAE 2025 Cisco 2025

Do you have an integration or workflow solution across the multiple technology systems in the trust?

There is no overarching product in place.

What are the key parts of your Digital Transformation and/or Hospital of the Future strategy going forward?

Migrating paper to digital alternatives and making the right information available to the right

person, without delay.

What adoption of Internet of Things has been implemented? Do you have an IOT containment policy?

IOT segmented by firewall.

What adoption of asset tracking/real-time asset monitoring or RFID has been implemented or is being considered or planned? Does this include patient flow? Can you confirm contract dates and vendors?

This is in place for theatre equipment. It is non-RFID based.
