Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

We can confirm that we do hold the information you are requesting

Could you please let me know

- a) The number and variety of point of care equipment that is utilised within your trust There are approximately 400 POCT devices across the Trust. These comprise the following types of device:
- Blood gas analyser (benchtop)
- HbA1c analyser
- Blood gas analyser (handheld)
- Glucose / ketone meter
- Coagulation timer (INR)
- Coagulation timer (activated clotting time)
- Thromboelastography
- Full blood counter
- Haemoglobin meter (handheld)
- Viral RNA PCR machine
- Placental growth factor analyser
- Fetal fibronectin analyser

b) The numbers and grades of staff that employed to cover the point of care testing requirements within the trust

The point of care testing itself is undertaken by suitably trained staff in the clinical areas in which the devices are situated. In many cases, it is also the ward staff who are responsible for the maintenance, quality assurance, and training aspects of the POCT service. For other POCT devices, these aspects are managed centrally. The staff who undertake these duties are also employed to perform non-POCT related duties. It is therefore difficult to estimate the equivalent number of staff who 'cover the POCT requirements within the trust'. There is one associate practitioner who spends the majority of time on POCT duties. The other staff who

support POCT spend only a small minority of their time on this area. This pool of staff contains six individuals.
