- The Trust calculates absences in FTE days so we have provided in the above format to be more reflective of our reporting methods.
- This only includes data from Weston General Hospital from July 2020 following the merger.
- Sickness data will only include long Covid absences before September 2022 as any other Covid related absence was recorded as a non-sickness absence. Therefore only 2022/23 includes all Covid absence and only from September 2022 onwards.
- The data relating to stress or anxiety is based on the national sickness code for Anxiety/stress/depression/other psychiatric illness
