Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

We can confirm that we do hold the information you are requesting

Q1. How many patients have been treated for advanced (FIGO Stages III and IV) ovarian (epithelial ovarian, fallopian tube or primary peritoneal) cancer over the last 3 months? Please note, the Trust does not hold the data in a format that would enable us to fully respond to your request to the level of detail required and a manual trawl for this information would significantly exceed the 18 hours limit set down by the FOI as the reasonable limit. Section 12 of the FOIA provides that we are not obliged to spend in excess of 18 hours in any sixty-day period locating, retrieving and identifying information in order to deal with a request for information and therefore we are withholding this information at this time.

If none, do you refer advanced ovarian cancer patients to another trust, and if so which one?

No, not applicable.

Q2. How many ovarian cancer patients (any stage) have been treated in the last 3 months with:

- Paclitaxel in combination with a platinum-based compound 14
- Platinum-based therapy alone (cisplatin or carboplatin) 10
- Bevacizumab in combination with paclitaxel and carboplatin *
- Olaparib 7
- Olaparib + Bevacizumab 0
- Niraparib 8
- Rucaparib *
