Please note: Where the figures are between 1 and 5, this has been denoted by *. Due to the low numbers, we have considered that there is the potential for individuals to be identified from the information provided, when considered with other information that may also be in the public domain. In our view disclosure of these low figures would breach one of the Data Protection Principles set out in Schedule 1 of the Data Protection Act, namely Principle 1. The Trust therefore finds that the Section 40(2) exemption contained within the Freedom of information Act 2000 is engaged. (Section 40 is the exemption for personal information).

We have included the hospital division for each answer. Please share any formal or informal criteria, policies, procedures, or similar the trust currently uses or has used from 2015 - 2023 to determine how:

- (a) A patient's debt is managed
- (b) The trust agrees upon the value of a patient's monthly repayment plan.

The extract below is taken from a review of the processes carried out last year:

When making decisions regarding affordability, the Income Recovery Lead at NHS Improvement have signposted the Trust to the Standard Financial Statement (SFS). SFS is a debt advice tool used to summarise a person's income and outgoings, along with any debts they owe.

By using this tool, the Accounts Receivable team can quickly assess a patient's income and expenditure and make a decision in conjunction with the patient regarding repayment and affordability. If the output suggests the patient cannot pay and the patient may be destitute, the Accounts Receivable Manager can use the tool to create a case for the invoice to be written off.

For each financial year from 2015-2023, please provide the total number of patients whose information has been shared with the Home Office in relation to a debt:

- (a) Greater than £500 owed for more than 2 months
- (b) Greater than £500 owed for less than 2 months
- (c) Less than £500

We are legally obliged to share Overseas Visitors debtor data with the Department of Health and Social Care (DHSC) when that debt is for £500 or more and aged 60 days+. The DHSC share that data with the Home Office, but we do not have sight of that submission. On that basis we cannot answer the question posed as we cannot be certain of the information flow between DHSC and Home Office.
