# What was your hospital trust's total budget (Sterling) allocated for inpatient food for the years a) 2018, b) 2019, c) 2020, d) 2021, e) 2022

As we report on the data based on the use of the NHS Model Hospital data we do not undertake an exercise to calculate the budget only the spend provided below. The NHS Model Hospital defines the cost of inpatient food as "The gross cost of in-patient food services includes staff and provisions costs but excludes treatment related food services such as nutritional supplements. Food costs exclude management costs to obtain direct costs of providing inpatient food services. Management costs were reported separately as "Management (hard and soft FM)" costs. An in-patient meal is defined as either breakfast, midday or evening meal order (or any substitute or alternative for any such meals) received by an in-patient (wards and departments).

# What did your hospital trust spend (Sterling) in total on inpatient food for the years a) 2018, b) 2019, c) 2020, d) 2021, e) 2022

2018/2019: £4.295m 2019/2020: £5.624m 2020/2021: £5.446m 2021/2022: £5.878m 2022/2023: Data not available. The national data return is not due to be submitted until July 2023.

The average daily cost per day (Sterling) and per patient, allocated to feed an inpatient with normal non-exceptional dietary requirements staying in your hospital trust for the years a) 2018, b) 2019, c) 2020, d) 2021, e) 2022

2018/2019: £12.63 2019/2020: £12.72 2020/2021: £14.88 2021/2022: £14.40 2022/2023: Data not available. The national data return is not due to be submitted until July 2023.

The information provided is for the financial year which runs from April to March. Please note that in 2020/21 the Trust merged with Weston Hospital and their data was incorporated into the Model Hospital as a joint organisation.
