Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

Please answer the following questions regarding your long covid paediatric hub for children and young people:

1. Please disclose how many children and young people are currently awaiting treatment – either a first assessment or otherwise – for post-covid syndrome at your hub. This should be at the time of the FOI's submission or completion, whichever is later, to capture the figure as accurately as possible.

Zero. There is no waiting list for long Covid services in the Trust.


- If you hold historical data as to how many patients were waiting during a particular month then please disclose this as well. For instance, in December 2019, [X] patients had been waiting longer than [Y] weeks for their first assessment for post-covid syndrome

2. Please disaggregate this data where possible. I understand it may be separated by those waiting longer than six weeks, 12 weeks, 18 weeks and so on as an example. If this is the case, then please do so.

The information below covers the period 1 October 2021 to 4 December 2022 and is taken from the data that we submit to NHSE (NHS England):

The waiting time from referral to initial specialist assessment at the Trust's long Covid hub for children and young people since it began operating, broken down as follows: 0-6 weeks, 6-12 weeks, 12-18 weeks, more than 18 weeks

0-6 weeks	118

Please note: Where the figures are between 1 and 5, this has been denoted by \*. Due to the low numbers, we have considered that there is the potential for individuals to be identified from the information provided, when considered with other information that may also be in the public domain. In our view disclosure of these low figures would breach one of the Data Protection Principles set out in Schedule 1 of the Data Protection Act, namely Principle 1. The Trust therefore finds that the Section 40(2) exemption contained within the Freedom of information Act 2000 is engaged. (Section 40 is the exemption for personal information).

We don't report individual patient wait times but instead report in categories as follows:

There were 8 referrals received to the service after 4th December. These were not assessed

before it closed and will have been referred to another hub.
