Dear Sir/Madam

Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

- We can confirm that we do hold the information you are requesting
- 1. In the last 2 years (2021 2023), how many (if any) Datix's or other reportable events have occurred in your trust which have involved a patient fall from a patient trolley or stretcher?

There were 579 incidents in the last 2 financial years (1 April 2021 to 31 March 2023) where the sub-category is 'Fall from bed/trolley' - we do not have 'stretchers' as a category or sub-category.

2. In the last 2 years (2021-2023), how many (if any) Datix's or other reportable events have occurred in your trust that have involved a patient trolley or stretcher in any way? Please outline or explain any events.

There were 3562 incidents affecting patients in the last 2 financial years where 'trolley' or 'stretcher' is mentioned in the incident description In addition there were also 8300 incidents in the last two financial years where the following sub-categories were used - '12 hour trolley breach', '12 hour trolley breach (adult only)' and '12 hour trolley breach (paediatric only)'. We have not provided explanations to these events as we have considered that there is the potential for the individuals to be identified, when considered with other information that may be in the public domain. In our view disclosure of information would breach the Data Protection Act. Therefore please find that Section 40(2) exemption contained within the Freedom of Information Act 2000 is engaged. Section 40 is the exemption for personal information.

This concludes our response. We trust that you find this helpful, but please do not hesitate to contact us directly if we can be of any further assistance.

If, after that, you are dissatisfied with the handling of your request, you have the right to ask for an internal review. Internal review requests should be submitted within two months of the date of receipt of the response to your original letter and should be addressed to:
