Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

- We can confirm that we hold some of the information you are requesting

Q1 - How many patients has your Trust treated in the past 3 months for:

- **Non-small cell lung cancer (NSCLC) - any treatment**

Unable to tell due to lack of information for surgical and radiotherapy patients

- **Non-small cell lung cancer (NSCLC) - surgical treatment**

Unable to tell from our e-prescribing system

- **Non-small cell lung cancer (NSCLC) - radiotherapy**

Unable to differentiate between subcategories of lung cancer. Total lung cancer patients having radiotherapy (any type) - 46

- **Non-small cell lung cancer (NSCLC) - systemic anti-cancer treatment (SACT)**

We do not hold this information due to the vast number of ways patient can be referred to palliative care services, some of which bypass University Hospitals Bristol and Weston NHS Foundation Trust entirely.
