# 1) How many incidents were reported by your Trust on the Datix incident reporting system under the category 'MRI safety'?

There is no category for MRI Safety. There are 66 non-rejected incidents reported under the sub-category of 'MRI Incident' in the current Datix system (incidents reported June 2015 to July 2023).

# 2) How many of these MRI safety Datix incident reports were listed under the division, 'MRI Non Declared Internal Passive Metallic Implant'?

We do not have a subcategory/division called 'MRI Non Declared Internal Passive Metallic Implant' so cannot provide the information as requested.

### 3) How many of these MRI safety Datix incident reports were under the division 'MRI Non Declared Internal Active Metallic Implant'?

We do not have a subcategory/division called 'MRI Non Declared Internal Metallic Implant' so cannot provide the information as requested.

# For all of the incidents captured under 2 and 3 above in 2022/23, can you please provide a verbatim copy of the description of the adverse event?

We do not have subcategories/divisions called 'MRI Non Declared Internal Passive Metallic Implant' or 'MRI Non Declared Internal Metallic Implant' so cannot provide the information as requested.
