Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

Please note: Where the figures are between 1 and 5, this has been denoted by *. Due to the low numbers, we have considered that there is the potential for individuals to be identified from the information provided, when considered with other information that may also be in the

public domain. In our view disclosure of these low figures would breach one of the Data Protection Principles set out in Schedule 1 of the Data Protection Act, namely Principle 1. The Trust therefore finds that the Section 40(2) exemption contained within the Freedom of information Act 2000 is engaged. This follows NHS Digital (formerly HSCIC) analysis guidance (2014) which states that small numbers within local authorities, wards, postcode districts, providers and Trusts may allow identification of patients and should not be published.

Does the screening coordinator provide all, the majority, or none of the counselling for high chance results? Who else supports this?

For all high chance FTCS (First Trimester Combined Screening) results received from the lab; the screening midwives will provide the counselling. Plus providing the counselling and giving of results for high chance NIPT results (except if the NIPT was requested by FMU (Fetal Medicine Unit) ie. non-pathway). For all high chance NIPT they are referred to FMU to be counselled there as well by the consultants.

Screening midwives do not staff the FMU unit and are therefore not present during FMU consultations

Surgical termination is not supported by the screening team in terms of hours

Do you provide training for midwives on a mandatory day (how many hours) or how do you give updates to midwives?

Midwives attend a mandatory maternity specific update every 2 years and we provide a 90-minute training session on screening and its updates
