Dear Sir/Madam

Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

• We can confirm that we do hold the information you are requesting

1-Details of the Intraoperative Neuromonitoring (IONM) services offered, including but not limited to:

a. Types of surgeries or procedures for which IONM services are utilised.

Neurophysiology (paediatrics only) Spinal (paediatrics only)

b. The specific conditions or indications that warrant IONM during surgeries.

Indications for motor mapping are primarily related to the proximity of any existing lesion to the motor and sensory cortices, or the need to identify the central sulcus for TPO disconnection. ECoG has been used primarily to define the borders of the identified lesion and guide the extent of the resection.

2- Information about the referral process for patients requiring Intraoperative Monitoring Services, including how patients are assessed and referred for IOM. Surgical cases are identified through the Children's Epilepsy Surgery Surgery's (CESS's) Multi-Disciplinary Team (MDT) meetings, when the results and data from each specialities' pre-surgical workups are presented.

3- Statistics or data on the utilisation of Intraoperative Neuromonitoring Services for the past two calendar years, broken down by year. This should include the total number of procedures involving IONM, as well as a breakdown of the types of surgeries or procedures.
