Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

We can confirm that we do hold the information you are requesting

Please provide the following information for each calendar year from 2018 to the present (2023):

What was the longest a patient at your healthcare facility waited (in weeks/days) for -

a) a first consultation with a radiation oncologist, following a referral for radiotherapy treatment;

Our systems do not capture this information; however, we can advise that current waiting times for New Patient appointments across our specialities is currently on average 2 to 4 weeks depending on tumour site.

b) the initiation of radiotherapy treatment, following the initial consultation with a radiation oncologist:

We are able to obtain this information however we have decided to apply Section 21 of the FOIA as this information is reasonably accessible in the public domain on the following link on the NHS England website: <a href="https://www.england.nhs.uk/statistics/statistical-work-areas/cancer-waiting-times/monthly-prov-cwt/2023-24-monthly-provider-cancer-waiting-times-statistics/provider-based-cancer-waiting-times-for-april-2023-24-provisional/

d) a diagnostic test or procedure related to radiotherapy planning, following the referral from a radiation oncologist.

The number of unresolved radiotherapy referrals

We have 101 patients on our list waiting to start radiotherapy, all but 21 patients have a Planning CT Scan booked.

and the longest length of time the referral has been pending.

We have not provided the information in the requested format as we have considered that there is the potential for the individuals to be identified, when considered with other information that may be in the public domain. In our view disclosure of information would breach the Data Protection Act. Therefore please find that Section 40 (2) exemption contained within the Freedom of Information Act 2000 is engaged. Section 40 is the exemption for personal information.
