Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

We have not provided the information in the requested format as we have considered that there is the potential for the individuals to be identified, when considered with other information that may be in the public domain. In our view disclosure of information would breach the Data Protection Act. Therefore please find that Section 40 (2) exemption contained within the Freedom of Information Act 2000 is engaged. 2. Do any of these diagnoses / records mention batons, pepper spray or shield inflicted wounds? If so, how many?

The word 'protest' was recorded eight times.

3. Please can you provide a spreadsheet detailing the first diagnosis of people treated in A&E between 17:00 14/3/2021 and 12:00 15/3/2021 in Bristol's main A&E hospitals (BRI and Southmead)?
