Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

- We can confirm that we hold some of the information you are requesting
- 1. The total number of expectant mothers registered at your trust, broken down by financial year, since 2010.

We have only been able to provide data from May 2012 due to a change in maternity systems

2. The number of expectant mothers registered at your trust, who have been informed

that NHS provided in-person antenatal classes are full, broken down by financial year, since 2010.

All women are provided information about antenatal classes during their pregnancy. We do not hold virtual sessions, only face to face.

3. The number of expectant mothers registered at your trust, who were able to access NHS provided in-person antenatal classes, by financial year, since 2010.

Class access is captured on attendance sheets in various areas such as Brislington, Keynsham, Hartcliffe, Knowle, Knowle West, Whitchurch and Stockwood. Please note, the Trust does not hold the data in a format that would enable us to fully respond to your request to the level of detail required and a manual trawl for this information would significantly exceed the 18 hours limit set down by the FOI as the reasonable limit. Section 12 of the FOIA provides that we are not obliged to spend in excess of 18 hours in any sixty-day period locating, retrieving and identifying information in order to deal with a request for information and therefore we are withholding this information at this time.

4. If antenatal classes are provided virtually, how many expectant mothers registered at your trust viewed these classes online, by financial year, since 2010.

The only virtual classes we offered were implemented during Covid and are on the Trust website. There are various You Tube videos providing specific information e.g. virtual tour, as extra information but we do not record numbers viewed.

This concludes our response. We trust that you find this helpful, but please do not hesitate to contact us directly if we can be of any further assistance.

If, after that, you are dissatisfied with the handling of your request, you have the right to ask for an internal review. Internal review requests should be submitted within two months of the date of receipt of the response to your original letter and should be addressed to:
