Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

We can confirm that we hold some of the information you are requesting

I would also like to research the number of out-of-area (OOA) placements as well as the number of people with a delayed transfer of care (DTOC) in an in-patient setting for the following condition:

i.) Acquired Brain Injuries (ABI) condition – Patients in a level-3 neuro-rehab facility in-patient bed.

Type of care	Out of Area Placements (OOA) cases as of Oct 31st (or latest available)	Delayed Transfers of Care (DTOC) cases as of Oct 31st (or latest available)
Acquired Brain Injury (ABI)	*	0

Notes:

ABI refers to a patient occupying an in-patient bed in a level-3 neurorehabilitation facility and being treated for an acquired brain injury

Definitions

Out of Area Placements (OOA) cases - 2023

This is classified as the total number of patients currently in an in-patient setting receiving care in your trust who are from an outside ICB and funded by that ICB in 2023 Delayed Transfers of Care (DTOC) cases - 2023

This is classified as the total number of patients in your trust that you are caring for who are currently awaiting a transfer of care into a community setting in the region but are currently unable to get one as of 2023

Please note - Due to the way the Trust's coding system records these patients, we can only provide this figure for patients that have been discharged from the Trust. Adult neurology service is provided by North Bristol NHS Trust. Please contact foi@nbt.nhs.uk for further information.

* Please note: Where the figures are between 1 and 5, this has been denoted by *. Due to the low numbers, we have considered that there is the potential for individuals to be identified from the information provided, when considered with other information that may also be in the public domain. In our view disclosure of these low figures would breach one of the Data Protection Principles set out in Schedule 1 of the Data Protection Act, namely Principle 1. The Trust therefore finds that the Section 40(2) exemption contained within the Freedom of information Act 2000 is engaged. This follows NHS Digital (formerly HSCIC) analysis guidance (2014) which states that small numbers within local authorities, wards, postcode districts, providers and Trusts may allow identification of patients and should not be published.

If, after that, you are dissatisfied with the handling of your request, you have the right to ask for an internal review. Internal review requests should be submitted within two months of the date of receipt of the response to your original letter and should be addressed to:
