Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

- **ALK Inhibitors (Alectinib, Brigatinib, Ceritinib, Crizotinib, Lorlatinib): 18**
- **Amivantamab: 0**
- **Atezolizumab Monotherapy: ***
- **Atezolizumab + Bevacizumab + Carboplatin + Paclitaxel: 0**
- **Dabrafenib + Trametinib: ***

- **Vinorelbine monotherapy or in combination with Carboplatin/Cisplatin:** 13
- **Other active systemic anti-cancer therapy (SACT):** 4
