2. Between the 19th March – 15th April 2020 how many patients from your hospital(s) were discharged into residential care/nursing home? 119 patients

Of those discharged in question 2 how many were tested for COVID-19? patients

Before April 15th the national guidance was not to test patients for Covid-19 before discharge to a care home. The national guidance was updated on April 16th with the move to a policy of testing all patients being discharged to care homes from hospital. Imminent discharges were already in progress as this was rolled out. All referral forms for discharges to care homes included the patient's current Covid information (i.e.

patient symptomatic or asymptomatic), plus whether they had been on a ward with Covid-positive patients. These referral forms were provided to the care homes at the point of handover. All care homes accepted these patients and appropriate PPE was sent with the patients as required.

- 4. Of those who were tested COVID-19 from question 3, how many:
 - a. Tested positive for COVID-19

1 patient

b. How many tested negative for COVID-19

15 patients

- c. How many did not have the results before the patient was discharged?
- d. Results were inconclusive
