Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

We can confirm that we do hold the information you are requesting.

**1. How many Endoscopy Procedures were delivered via insourcing providers between Jan 2019 and Dec 2019?**

The Trust has commenced insourcing procedures with Glanso in November 2019.  
Between November and Dec 2019 the Trust performed 8 Glanso lists.  
23 patients in November and 22 in December.  
Total of 45 patients.

**2. How many Gastroenterology Outpatient clinics were provided by an insourcing provider between Jan 2019 and December 2019?**

Total number of clinics: 449 for the service. Please see below the breakdown.  
Consultant Clinics: 143  
Registrar Clinics: 72  
IBD Nurse Clinics: 194  
Nutrition Team Clinics: 33  
Transition Clinics with Bristol Children's Hospital: 3  
Joint Medical & Surgical Clinics: 4

**3. How many Ophthalmology Procedures were delivered by an Insourcing provider between Jan 2019 and December 2019?**

743 Ophthalmology procedures.

**4. How many dermatology procedures were provided by an insourcing provider between Jan 2019 and December 2019?**

568 Dermatology procedures.
