Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

We can confirm that we do hold the information you are requesting

- 1. Is there a written plan for return to ophthalmology and Cataract surgery at the Hospital? Yes.
 - Please share if possible
 Please see attached.
- Are there dates for Planned Return for the trust to start Cataract Surgery?
 Yes pilot/ cycle 1 (Plan, Do, Study, Act) PDSA 3rd July dependencies on PPE, staffing and testing capacity.
- 3. Are there any further details on
 - a. A phased return to Ophthalmology/Cataract surgery (25% 50% 75% 100%)? Ambition to test at 50% 3rd July 2020 and return to 75% in current plan with some timetable review to be completed but not yet clear if 100% will be feasible until we have extended working days and or working on other sites (IS) etc.
 - b. A set timeline on the phased return to Ophthalmology / Cataract surgery? No set timeline due to unknown factors beyond our control however gradual increase anticipated within practical limitations Increase from one day per week to 2 then 3 with surgeon availability social distancing, PPE, testing and risk. Controls are in place within Trust Theatre Prioritisation group to ensure patients are prioritised appropriately according to clinical urgency and Trust resource capacity.
- 4. How is Cataract surgery being prioritised?
 - a. If there is a grading system please clarify the details?
 Cataract surgery is prioritised by risk stratification process however within Ophthalmology patient cohort cataracts were not high priority.

The variables used are taken from the Royal College of Ophthalmology recommendations, but simplifying them as binary variables. These are:

Covid:

- VA 6/24 or worse
 Limitation Activity, falls risk, terminal, needed for care
- o Symptomatic anisometropia
- o Age >75
- Shielding conditions
- Any Covid-19 complications risk increasing condition
- Guarded prognosis

Eye Surgery factors

- Positioning/mobility
- o Compliance with the procedure
- Very small or very large eyes. AL <22 or >26, ACD <2.5
- Previous major incisional eye surgery TBC/PPV/PKP
- o Any condition increasing risk of lens dislocation. PEX/trauma/donesis
- Small pupil
- Corneal opacity precluding view of the cataract
- Any condition risking endothelial damage such as Fuchs
- Very dense cataract leading to poor or No fundal view
- Posterior polar cataract
