Dear Sir/Madam

Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

We can confirm that we do hold the information you are requesting.

1. We will be grateful if you can provide anonymised data (number of children, their age at diagnosis and gender) of all children below the age of 16 years who were diagnosed in your hospital with achalasia (ICD code K22.0).

Patient Age	No of Patients

6-10	<5
11-15	15

Please note that as there were no time parameters on this request the Trust has applied the same date parameters as in question 2 as a default.

Please also note that we had to group the age and separate the gender data to avoid low numbers. Where the numbers are low, we have considered that there is the potential for the individuals to be identified from the information provided. In our view, disclosure of these low figures would breach one of the Data Protection Principles set out in Schedule 1 of the Data Protection Act, namely Principle 1, therefore find that the Section 40(2) exemption contained within the Freedom of information Act 2000 is engaged. Section 40 is the exemption for personal information

2. Separately, also provide the number, age at time of operation and gender of children who have had myotomy (OPCS code G09.1) between April 2008 to April 2020.

The number of patients who have had myotomy is less than 5.

Where the numbers are low, we have considered that there is the potential for the individuals to be identified from the information provided. In our view, disclosure of these low figures would breach one of the Data Protection Principles set out in Schedule 1 of the Data Protection Act, namely Principle 1, therefore find that the Section 40(2) exemption contained within the Freedom of information Act 2000 is engaged. Section 40 is the exemption for personal information.
