Dear Sir/Madam

Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

- We can confirm that we do hold the information you are requesting
- Letters sent to expectant women advising of screening tests following combined/quadruple screen testing for Down Syndrome. I understand the letter may be different depending on whether results are low or high chance so please send examples of each.
- Letters/results from Non-Invasive Prenatal Testing (NIPT), again high and low chance examples if different.
- Examples of information eg. letters, leaflets, signposting etc. shared with expectant women about these tests (combined/quadruple screening and NIPT).
- Any information shared with expectant women about Down Syndrome itself (including guidance on pregnancy/care when given an antenatal diagnosis).

The letter that is sent for low chance results is a standardised letter that is printed. Please see the attached documents.

We don't send letters for high chance results. We phone all women to offer face to face appointment to discuss high chance result.

We discuss the result and their options. We give them our contact details and ask them to contact us if they would like an invasive/diagnostic procedure. We also ask them if we don't hear from them, that they are happy to be contacted in a couple of weeks for a follow up call. We currently don't send a letter. We realise that when we contact the lady to discuss results and options, it is a lot of information to absorb. We have created a letter that we want to send following the telephone counselling session – this letter will summarise what has been discussed and give links etc for further information. The letter is in the process of being approved for use by the FMU consultants and appropriate working parties/governance meetings. Once the letter has been ratified for use I will send a copy. We send the high chance results to the lady's home address.

NIPT is currently not available on the NHS. When we contact women to discuss their result – we discuss NIPT. We signpost them to ARC (Antenatal Choices and Results) – they discuss local providers/ test results. The clinics who perform the NIPT discuss the results.

When women book their pregnancy they are signposted to the 'My Pregnancy at St Michael's 'app and advised to read the information regarding first trimester screening. From April 2021 it is proposed that all screening information will be accessed digitally. Midwives will still be able to print off paper versions for those women that don't have access to digital information / digital information may not be appropriate. FTCS will be discussed further at the booking appointment.

Maternity services are in the process of creating a new letter to be sent when women book for delivery at St Michael's.

If, after that, you are dissatisfied with the handling of your request, you have the right to ask for an internal review. Internal review requests should be submitted within two months of the date of receipt of the response to your original letter and should be addressed to:
