Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

We can confirm that we do hold the information you are requesting

I'd like to request some information in regards to the following services. Listed Services:

a) Laundry equipment supply, maintenance and install.

Laundry is outsourced so we do not hold the information for this service.

b) Fire equipment supply, maintenance and install and provision of Fire Risk Assessments / consultancy.

DC Supply: fire alarms, dampers, fire stopping, fire doors, fire-fighting equipment, signage, consultancy, specialized system for helideck, AE; Maintenance – alarms, dampers, doors, fire stopping, fire-fighting equipment. Install: as required

c) HVAC equipment supply, maintenance and install.

DC Supply: portable HVAC equipment. Fixed systems such as heating, boilers, air con, filtration systems as required: Maintenance – PPMs Heating, boilers, air con, filtration systems; Install: as required.

1) Please confirm your annual spend for the listed services showing a breakdown of contract value and any additional ad-hoc spend for the previous 3 years.

There are over 160 contracts held for these services, gatherig the information for this would exceed the 18 hour time limit.
