- Dr Philip Cowburn, consultant in emergency medicine at the Bristol Royal Infirmary, was awarded an MBE in 2020 for services to pre-hospital care, in particular his involvement in the successful pilot of a new critical care transfer service, Retrieve
- The South West Critical Care Transfer Service, now known as Retrieve and hosted at UHBW, won the Excellence in Urgent and Emergency Care Award at the South West NHS Parliamentary Awards

- The speech and language therapy team at Weston General Hospital worked with Widgit Software to produce a Critical Care Communication Chart, to aid communication between medical staff and patients who are critically ill. This has been picked up by Communication Therapy International (a Royal College of Speech and Language Therapists Clinical Excellence Network) and CPLOL and is in the process of being translated into around 60 languages
- The rheumatology team received the Best Practice Award from British Society for Rheumatology, in partnership with Versus Arthritis, for their project which involved developing a set of courses to support osteoporosis patients to avoid hip and spinal fractures, with practical exercises to help them manage their condition
- Presented to the IHI forum international conference December 2020 on "Moving from a Top-Down to a Bottom-Up Improvement Approach: The Journey of an NHS Trust".
- Paper published in BMJ Leader 2020 "Taking phonership: an initiative to improve telephone access for patients receiving services at a dental hospital in the UK".
- Dr Anne Frampton, Consultant in Paediatric Emergency Medicine and Clinical Lead for Transformation, short listed for the HSJ clinical leader of the year 2020 category.
- PReCePT (Prevention of Cerebral Palsy in PreTerm Labour), winner of the HSJ Patient Safety Award in the Maternity and Midwifery Services Initiative of the Year 2019 category.
- The PReCePT initiative was shortlisted for Workforce Imitative of the Year at the 2020 HSJ Awards
