Dear Sir/Madam

Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

• We can confirm that we hold some the information you are requesting

1. How many public health funerals the trust has undertaken for patients who have died of Covid (within 28 days of the first positive test) with no known relatives or next of kin.

I'm looking for information relating to the period between March 2 2020 and March 2 2021. Can the information please be broken down by ethnicity, age and gender for each patient? If doing this exceeds the cost limit and the scope needs narrowing, could ethnicity be prioritised, followed by age, please?

we do not hold this information

2. How many Covid deaths (within 28 days of the first positive test) have been recorded by the trust between March 2 2020 and March 2 2021.

We are able to obtain this information however we have decided to apply Section 21 of the FOIA as this information is reasonably accessible in the public domain on the following link: <u>https://www.england.nhs.uk/statistics/statistical-work-areas/covid-19-daily-deaths/</u> Section 21 of the FOIA provides that we are not obliged to provide the requested information is already reasonably accessible and therefore we are withholding this information at this time.

3. How much a public health funeral typically costs the trust, and if possible, how much has been spent on public health funerals by the trust between March 2 2020 and March 2 2021.

We have a Hospital Funeral contract the cost is £1282 per funeral. March 2020 to March 2021 = £10,019.00

4. The relationship between the trust and the local authority/authorities when it comes to public health funerals and the processes involved in deciding who is responsible for arranging them.

If a patient dies in the hospital with no funds at all , we fund and arrange the funeral per

government guidelines . If the person dies with funds , house or money in a bank account then environmental health with deal with arranging/ paying and reclaiming money back as a favor. Environment health are responsible for people in the community with no funds.

5. What is provided by the trust at a public health funeral.

A basic funeral, which entails an early morning cremation at 9.30am lasting 20 minutes as costs considerably less, our hospital Chaplin does a 10 minutes service.
