Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

• We can confirm that we do hold the information you are requesting

I have some queries relating to the following data:

• Question 3 - Referral to first assessment – KPI NH2. Please could you give the overall average wait time in days (including the 2% who were seen later than 4 weeks)? Estimate 16 days

• Question 3 - Routine follow-up hearing aid review for existing PCHI not including glue ear. Please could you give the overall average wait time in days (including the other hearing aid review appts less than 1 month behind)? Estimate 20 days

• Question 13 - If you are registered with IQIPS but have not progressed in the last year, what is the main reason? Please select one answer:

o In Q11 the response I ticked says go to Q15 so I missed out Q13 and Q14 But if I was answering Q13 it would be "other"...we have progressed and will continue to make steady progress towards the standards without affecting our time seeing patients

• Question 14 - Has your service booked its onsite assessment with UKAS? Please select one answer:

No (go to question 18) ✓ Yes If yes, what is the date of your onsite assessment: MM/YYYY

• Question 23 - Would the new h/aids count as streamers as they have streaming ability?

I can confirm that they would not count as we mean separate devices to the hearing aid. So we have answered this in the end box "not provided by our service or the LA"
