Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

• We can confirm that we do hold the information you are requesting

I would like to know the number of deaths whereby covid-19 is the sole cause of death listed, where there were no other pre existing conditions or comorbidities noted on the death certificate, covering the period march 2020 until the present day. And are you able to tell me the average age of the deceased?

We are able to obtain this information however we have decided to apply Section 21 of the FOIA as this information is reasonably accessible in the public domain on the following link https://www.england.nhs.uk/statistics/statistical-work-areas/covid-19-daily-deaths/ Section 21 of the FOIA provides that we are not obliged to provide the requested information is already reasonably accessible and therefore we are withholding this information at this time.

I would also like to know the number of cycles you have been using on the PCR test as standard.

The Trusts laboratories have a number of assays in use for undertaking polymerase chain reaction (PCR) testing and each assay may have a slightly different limit of detection rate. The Trust complies with individual manufactures guidelines.
