Funding Information and Support Offer

NHSE&I are offering the following support:

- cover the initial implementation cost for the required interface(s), including required version upgrades on your LM or OH system.
- cover first year support costs for interface(s), including first year costs from ESR.
- technical assurance from NHSX for new interfaces to ensure they are compatible with NHSX data and interoperability standards.
- guidance throughout project implementation, including case studies and best practice. Individual NHS Trusts will need to fund the ongoing annual support costs from year 2 and beyond for their interface(s) with their suppliers and ESR.
