Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

I request the following details:

- Value or estimated value if applicable
- Whether the item was accepted or declined

- Role of staff member the gift was received by if known, e.g. nurse, doctor, midwife etc. We are able to obtain this information however we have decided to apply Section 21 of the FOIA as this information is reasonably accessible in the public domain.
