In terms of testing - there are pending national guidance changes to testing. We are compliant with the national approach currently, some of which is explained above but in summary:

• All emergency admissions tested by point of care assessments and if admitted as inpatient by PCR. Inpatients are screened on day 3 and day 7.

- All elective patients are screened pre-admission and then follow on for admission.
- Patient discharged to care homes are PCR tested.
