Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

- We can confirm that we hold some of the information you are requesting

**Q1. In the past 3 months (or the latest 3 months data you have available), how many melanoma patients were treated with:**

- **Bevacizumab (Avastin) 0**
- **Dacarbazine (DTIC) \***
- **Trametinib (Mekinist) 0**
- **Dabrafenib (Tafinlar) 0**
- **Ipilimumab (Yervoy) 0**
- **Vemurafenib (Zelboraf) \***
- **Nivolumab (Opdivo) 31**
- **Nivolumab + Ipilimumab (Opdivo + Yervoy) 0**
- **Pembrolizumab (Keytruda) 16**
- **Vemurafenib + cobimetinib (Zelboraf + Cotellic) 0**
- **Dabrafenib + Trametinib (Tafinlar + Mekinist) 18**
- **Braftovi (encorafenib) in combination with Mektovi (binimetinib) for BRAF V600 patients \***

- **Other active systemic anti-cancer therapy [please state] Tebentafusp \***
- **Palliative care only**

We do not hold this information due to the vast number of ways patient can be referred to palliative care services, some of which bypass University Hospitals Bristol & Weston NHS Foundation Trust entirely.

Please note: Where the figures are between 1 and 5, this has been denoted by \*. Due to the low numbers, we have considered that there is the potential for individuals to be identified from the information provided, when considered with other information that may also be in the public domain. In our view disclosure of these low figures would breach one of the Data Protection Principles set out in Schedule 1 of the Data Protection Act, namely Principle 1. The Trust therefore finds that the Section 40(2) exemption contained within the Freedom of information Act 2000 is engaged. (Section 40 is the exemption for personal information).

**Q2. In the past 3 months (or the latest 3 months data you have available), how many metastatic melanoma patients were treated with the following:**

- **Ipilimumab 0**
- **Ipilimumab AND Nivolumab 0**
- **Nivolumab 25**
- **Pembrolizumab 11**
- **Dabrafenib AND Trametinib 6**
- **Any Other Targeted Therapy (Dabrafenib /Encorafenib AND Binimetinib /Trametinib /Vemurafenib /Vemurafenib AND Cobimetinib) \***
- **Other active systemic anti-cancer therapy \***
- **Palliative care only**

We do not hold this information due to the vast number of ways patient can be referred to palliative care services, some of which bypass University Hospitals Bristol & Weston NHS Foundation Trust entirely.
