To provide greater opportunity for candidates who may not meet band 6 requirements to commence a career path in healthcare chaplaincy with development opportunities to progress to band 6 chaplain in a supportive environment. Funding is secured to enable progression to band 6.

## If there is a change, please give the whole-time equivalent that has been reduced or increased.

Remained the same overall although this period included the merger of two Trusts into one new Trust and the funding for a Muslim chaplain moved from grant funding to substantive funding.

# 12. What steps or initiatives has the Chaplaincy Team taken to increase the diversity of service provision within your Trust?

The department has secured substantive funding for a Muslim chaplain which was achieved in July 2021. The existing Muslim chaplain left, and we are currently recruiting for a new Muslim chaplain. Before Covid we had chaplaincy volunteers and we were training new volunteers from a range of faith backgrounds including Muslim, Buddhist, Humanist and Sikh. All volunteering was stopped at the start of Covid-19. We are just seeing a slow return of some volunteers to the hospital and would hope to recruit from different faith backgrounds again in the future. We currently have one honorary Muslim chaplain who is also a local Imam and we hope to recruit further honorary chaplains from a range of faith backgrounds in the future. Demographically, patient admissions by (identified) religion are Christian 36%, Muslim 2% and all other minority faiths combined 2%. Identified requests for pastoral, spiritual or religious support (PSR) are 74% Christian, 20% non-religious/not recorded, 5% Muslim, 1% other

minority faiths. Our chaplaincy workforce aims to reflect and respond to this data in meeting requests for PSR. We maintain very good links with community faith leaders who support the chaplaincy team and provide patient care by request.
