- Please provide every report (whether submitted monthly or quarterly) since Jan 1 2020. If it is not possible to provide the information requested due to it exceeding the cost of compliance limits, please work back from the most recent report

Please see the attached documents. The reports began to be submitted from June 2021 in response to the Ockenden Review of Maternity Services. Please note there are no reports for August due to the meeting not being held in this month.
