Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

- We can confirm that we hold some of the information you are requesting
- Number of patients who died with COVID-19 as the primary cause of death as documented in par 1a of the death certificate (in each month)

Please note, the Trust does not hold the data in a format that would enable us to fully respond to your request to the level of detail required and a manual trawl for this information would significantly exceed the 18 hours limit set down by the FOI as the reasonable limit. Section 12 of the FOIA provides that we are not obliged to spend in excess of 18 hours in any sixty-day period locating, retrieving and identifying information in order to deal with a request for information and therefore we are withholding this information at this time.

- Number of patients who died with COVID-19 as a secondary cause of death as documented elsewhere on death certificate (NOT in part 1a) (in each month)

 Please note, the Trust does not hold the data in a format that would enable us to fully respond to your request to the level of detail required and a manual trawl for this information would significantly exceed the 18 hours limit set down by the FOI as the reasonable limit. Section 12 of the FOIA provides that we are not obliged to spend in excess of 18 hours in any sixty-day period locating, retrieving and identifying information in order to deal with a request for information and therefore we are withholding this information at this time.
- Number of patients admitted with COVID-19 (in each month)

We are able to obtain this information however we have decided to apply Section 21 of the FOIA as this information is reasonably accessible in the public domain on the following link: https://www.england.nhs.uk/statistics/statistical-work-areas/covid-19-hospital-activity/
Section 21 of the FOIA provides that we are not obliged to provide the requested information is already reasonably accessible and therefore we are withholding this information at this time.

- Number of patients infected with SARS-CoV-2 while in hospital (in each month) 2020

Hospital Site	Number of probable hospital- acquired Covid- 19 infections (8- 14 days after admission)	Number of definite hospital- acquired Covid- 19 infections (>14 days)
Bristol Royal Infirmary site	203	244
Weston General Hospital site	80	101

Please note we are unable to break down the totals into months as per your request due to a system migration. Data is for the period 01 March 2020 – 31 May 2022

Please express the above data as monthly figures for the date range January 2020 - May 2022

- Number of beds in the hospital on January 1st 2020 930
- Number of ITU beds in the hospital on January 1st 2020 182
