Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

- We can confirm that we do hold the information you are requesting

Q1. How many patients have been treated for breast cancer (any stage) in the past 3 months with the following systemic anti-cancer therapies:

- **Abemaciclib + Aromatase Inhibitor (e.g. Anastrozole, exemestane, letrozole) 9**
- **Abemaciclib + Fulvestrant 13**
- **Anthracycline (e.g. doxorubicin or epirubicin) as a single agent ***
- **Atezolizumab +Nab-paclitaxel/Paclitaxel ***
- **Capecitabine as a single agent 36**
- **Eribulin as a single agent or in combination ***
- **Everolimus + Exemestane ***
- **Fulvestrant as a single agent ***
- **Lapatinib 0**
- **Neratinib 6**
- **Parp Inhibitors (Olaparib/Talazoparib) 0**
- **Palbociclib + Aromatase Inhibitor (e.g. Anastrozole, exemestane, letrozole) 76**
- **Palbociclib + Fulvestrant 22**
- **Pembrolizumab ***
- **Platinum (e.g. carboplatin or cisplatin) as a single agent ***
- **Ribociclib + Aromatase Inhibitor (e.g. Anastrozole, exemestane, letrozole) ***
- **Ribociclib + Fulvestrant 0**
- **Sacituzumab Govitecan 8**
- **Taxane (e.g. docetaxel, paclitaxel, nab-paclitaxel) as a single agent 34**
- **Taxane and/or Anthracycline in combination 102**
- **Trastuzumab as a single agent or in combination 152**
- **Trastuzumab emtansine 35**
- **Transtuzumab deruxtecan ***
- **Any other active systemic anti-cancer therapy 9**

Please note: Where the figures are between 1 and 5, this has been denoted by *. Due to the low numbers, we have considered that there is the potential for individuals to be identified from the information provided, when considered with other information that may also be in the public domain. In our view disclosure of these low figures would breach one of the Data Protection Principles set out in Schedule 1 of the Data Protection Act, namely Principle 1. The Trust therefore finds that the Section 40(2) exemption contained within the Freedom of information Act 2000 is engaged. (Section 40 is the exemption for personal information).

Q2. In the past 3 months, how many early/locally advanced breast cancer (Stages 1 to 3B) patients were treated with:

- **Abemaciclib + Aromatase Inhibitor (e.g. Anastrozole, exemestane, letrozole) 0**
- **Taxane and/or Anthracycline (monotherapy or in combination) 75**
- **Any other active systemic anti-cancer therapy ***

Please note: Where the figures are between 1 and 5, this has been denoted by *. Due to the low numbers, we have considered that there is the potential for individuals to be identified from the information provided, when considered with other information that may also be in the public domain. In our view disclosure of these low figures would breach one of the Data Protection Principles set out in Schedule 1 of the Data Protection Act, namely Principle 1. The Trust therefore finds that the Section 40(2) exemption contained within the Freedom of information Act 2000 is engaged. (Section 40 is the exemption for personal information).
