Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

- We can confirm that we hold some of the information you are requesting
- 1. How many patients has your trust treated (for any medical condition) in the past 3 months with the following drugs:
- Alphanate 0
- Alprolix 8
- BeneFIX *
- HaemateP 0
- Idelvion 0
- Refixia 0
- Rixubis 0
- Veyvondi 0
- Voncento 9
- Wilate 8
- Willfact 0

Please note: Where the figures are between 1 and 5, this has been denoted by *. Due to the low numbers, we have considered that there is the potential for individuals to be identified from the information provided, when considered with other information that may also be in the public domain. In our view disclosure of these low figures would breach one of the Data Protection Principles set out in Schedule 1 of the Data Protection Act, namely Principle 1. The Trust therefore finds that the Section 40(2) exemption contained within the Freedom of information Act 2000 is engaged. (Section 40 is the exemption for personal information).

- 2. How many patients have been treated in the past 3 months with:
- Gene therapy for Haemophilia B ONLY 0
- Desmopressin for Von Willebrand Disease ONLY *
- Tranexamic Acid for Von Willebrand Disease ONLY We do not have this information.

This is issued for minor bleeds or as an adjunct with desmopressin/factor.

Please note: Where the figures are between 1 and 5, this has been denoted by *. Due to the

low numbers, we have considered that there is the potential for individuals to be identified from the information provided, when considered with other information that may also be in the public domain. - Haemophilia B (any age) 41
