### 1. All correspondence with The Sam Buxton Sunflower Healing Trust since 1st January 2006

All correspondence with the Sam Buxton Trust was done via email with Trustees of the Sam Buxton Sunflower Healing Trust from 2017. This included funding of a Reiki Healer in the Teenage and Young Adult Cancer Service in Bristol. Funding was provided in a fixed-term basis to appoint a therapist for a period of 23 months, after which funding was taken over by another local charity. The therapist was employed in an honorary contract (attached).

## 2. All internal correspondence relating to the creation of the position(s) of reiki practitioner and/or spiritual healer

Please see the attached document (intent to fund, honorary contract and conditions of grant).

# 3. All internal procedures and guidance governing the creation and regulation of the position(s).
