i. MIS only: Is the MIS hospital only or integrated across hospital and community?

BadgerNet Maternity is used in hospital and across the community including clinics. BadgerNet Maternity has replaced the yellow handheld maternity book, so all assessments, hospital and community, are captured on the system. Our previous MIS was CareFlow Maternity. This was used in the hospital to record admission/discharge assessments and intrapartum care. It was only used in the community for bookings and a final community discharge. Other community assessments were recorded on paper.
