Thank you for your email dated 2nd April 2024 requesting a review of the Trust's response to your recent request for information.

The purpose of an Internal Review is to assess how your Freedom of Information request was handled in the first instance and to determine whether the original decision given to you was correct. This is an independent review and reviewers were not involved in the original decision.

A new image intensifier was purchased in 2020 via emergency capital. Due to the pandemic and lack of available and appropriate space in the dental hospital, it took some time for this to be operational. SPIN clinics restarted in the Bristol Royal Hospital for Children in September 2020 until February 2022, and in the Bristol Dental Hospital from April 2023 to present. We are still awaiting the procurement of Vidiview to support these clinics.

Your request for an internal review

I hope this email finds you well.

I am writing to express my disagreement with the response provided to a recent Freedom of Information request. The information I seek has been provided to me in the past for previous year data sets, and I find it reasonable to request it again for the years 2022 and 2023 to provide a comparison of UHBWs improvements in the cleft service.

It is crucial to note the distinction between primary lip and primary palate operations, as they are separate procedures with unique implications. The recent response from UHBW, which does not separate these data sets, seems quite unusual, particularly given the significance in outcome between the two operations as per the Harm review into the cleft service.

Therefore, I can I kindly request that you discuss with the freedom of information team to provide the information in the same format as my previous request (Ref: 21-482), covering unilateral and bi-lateral cleft lip and palate operations for the years 2022 and 2023, separately for primary lip and primary palate operations.

Your attention to this matter would be greatly appreciated.

Outcome of the review
