Dear Sir/Madam

Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

- We can confirm that we do hold the information you are requesting

1. Do you have documented procedures for the taking of blood cultures in adult patients from both a peripheral and a central venous access device? (And able to provide an electronic copy of this/these documents?)

Please see the attached document.

2. Does your microbiology service have 2023 data relating to the % contamination rate of blood cultures from adult patients (This may be a month-by-month rate or an annualised rate)

Peripheral BC contamination rate in 2023 for Bristol Site 3.6%, Weston site 7.3%

3. Does your microbiology service have 2023 data relating to the % positivity rate of blood cultures from adult patients (This may be a month-by-month rate or an annualised rate)

9.8% +ve Bristol Site & 14.6% Weston Site for 2023

4. Does your microbiology service provide differential time to positivity analysis for blood cultures from adult patients (as a means of diagnosing central line-related bacteraemia)?

Yes

5. Does your microbiology service use automated blood culture analysers that have the facility to weigh and estimate the volume of blood with the culture bottles?

No

6. For the diagnosis of (Central) "line infections", which diagnostic criteria is used:

- CRBSI
- CLABSI

• **Another diagnostic criterion (Please state, if possible)** - Other. Microbiology team does not use a single criterion to diagnose central line infection. The diagnosis often involves input from other specialist teams, such as ICU and medical teams caring for the patient and they will use their own criteria to inform the clinical discussion, leading to a mutual derived conclusion.
