A new business intelligence approach to capturing such data is being created in-line with the Bristol, North Somerset and South Gloucestershire Integrated Care Board (BNSSG ICB). All patients that are discharged receive either a personalised 'safety plan', or collaboratively agreed plan also shared with their GP.

Please specify what plans the trust has in place to mitigate risks from rising numbers of patients attending A&E with mental health concerns.

Mental health activity (in terms of Emergency Department attendance) is monitored, audited and, if required, is recorded on Divisional and Corporate Risk Registers. This activity and risks are reported via the Adult Mental Health Operational Group, Mental Health Assurance Group, and Safeguarding Steering Group to the Trust Board and to BNSSG ICB.

The Liaison Psychiatry Service is able to adapt its service delivery to meet acute increases in demand in the Emergency Department. The data collated has been used to secure additional nursing and consultant psychiatrist posts in the Trust. There is regular interface and close working with system mental health partners via the BNSSG ICB networks and local mental health networks, to further mitigate risks.
