Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

- We can confirm that we do hold the information you are requesting

1) In your Trust is there a “cap/limit” on the number of absorbent continence pads provided per patient in each 24-hour period

If so, what is the number?

2) How much has your Trust actually spent on absorbent continence products during each of the last 5 financial years, and what is the annual budget for absorbent continence products during each of those years? Please give a figure for each year 2018/19, 2019/20, 2020/21, 2021/22, 2022/23.

- **2018/2019** - £87,000
- **2019/2020** - £75,000
- **2020/2021** - £65,000
- **2021/2022** - £76,000
- **2022/2023** - £100,000

Please note that we do not set budgets at the level of individual products so we are unable to provide this information.

3) What is the total annual number of patients in receipt of absorbent continence products in your trust? Please give a figure for each year 2018/19, 2019/20, 2020/21, 2021/22, 2022/23.

Please note, the Trust does not hold the data in a format that would enable us to fully respond to your request to the level of detail required and a manual trawl for this information would significantly exceed the 18 hours limit set down by the FOI as the reasonable limit. Section 12 of the FOIA provides that we are not obliged to spend in excess of 18 hours in any sixty-day

period locating, retrieving and identifying information in order to deal with a request for information and therefore we are withholding this information at this time.
