The clinic offers multi-disciplinary team model of care. The patients have access to medical, nursing, dietetic and psychology support. A combination of these are offered depending on the clinical need.

Patients are seen within face-to-face clinics across Trust sites. There are virtual clinics and also occasional home visits where appropriate.

How long do treatment programmes continue for?

The care pathway can range up to 18-24 months.
