Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

• We can confirm that we do hold the information you are requesting

• Do you directly purchase holter monitors which are reusable, which company/companies and products do you use (e.g.Spacelabs)? Yes, Spacelabs

o How much do you pay per monitor and what are the service costs? £7,623, approximately £4148.40 for contract maintenance)

o How much do you pay for the analysis software per licence? $\pounds 3,768$

o How many tests do you perform with these holter monitors per annum? 3900

o Approximately how many devices do you purchase per annum? Eight

• Do you purchase outsourced analysis holter monitors, either single use disposable holter monitors (e.g. iRhythm-Zio) and/or reusable devices (e.g. ECG on Demand, Express Diagnostics), which company/companies and products do you use? Yes, Zio patches

o How much do you pay per holter monitor/test? £200

o What is the average test duration? 14 days

o How many tests do you perform with these holter monitors per annum? 200

o Are you under official contract with this supplier? If so, until when?

Yes, for Same Day Emergency patients only. We have a contract for 200 monitors, once these monitors are used our contract ends.

• Do you have a current backlog of patient's for holter monitoring that falls outside of your KPI's?

Yes

o How many patients in total? 1294

o How many weeks is the current wait time for fitting?

Routine patients: approximately 40 weeks Urgent/stroke patients: Approximately 6 weeks

o Do you have a backlog for analysis? If so, how many?

Yes, 3 weeks
