Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

Please could you provide information relating to Trainee Nurse Associate foundation degree apprenticeships currently offered by the University Hospitals Bristol and Weston Trust.

1. In each year since the Trust started offering an apprenticeship scheme for Nurse Associates, how many students have enrolled as Trainee Nurse Associate Apprenticeship scheme whilst undertaking the level 5 foundation degree. If possible, please indicate how many intakes of students there were in each year and how many trainees enrolled in each intake.

The main reasons are: relocated area.

Please note that we have not provided this information in the requested format due to the low numbers, we have considered that there is the potential for individuals to be identified from the information provided, when considered with other information that may also be in the public domain. In our view disclosure of these low figures would breach one of the Data Protection Principles set out in Schedule 1 of the Data Protection Act, namely Principle 1. The Trust therefore finds that the Section 40(2) exemption contained within the Freedom of information Act 2000 is engaged. (Section 40 is the exemption for personal information).

5. Of those trainees who have successfully completed their apprenticeships, by individual cohort and/or year of intake, how many are working within the UHBW Trust as a Nursing Associate

Of the students who successfully have successfully completed their apprenticeships, by cohort or year of intake, how many and/or what percentage have continued on to study for a degree, apprenticeship or otherwise, leading to qualification as a Registered Nurse and how many have, to date, have successfully completed the process.
