Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

- We can confirm that we do hold the information you are requesting

**Q1. Do you treat patients for Urothelial cancer (Yes or No)?**

Yes

**Q2. How many patients were treated for Urothelial cancer (any stage) in the past 3 months with the following treatments:**

- **Atezolizumab (Tecentriq):** - 6
- **Avelumab (Bavencio):** - \*
- **Carboplatin single agent or in any other combination:** - 0
- **Carboplatin with Gemcitabine:** - 9
- **Carboplatin with Paclitaxel:** - 0
- **Cisplatin single agent or in any other combination:** - 0
- **Cisplatin with Gemcitabine:** - 8
- **Cisplatin with Gemcitabine + Nivolumab (Opdivo):** - 0
- **Enfortumab Vedotin + Pembrolizumab (Padcev + Keytruda):** - 0
- **Nivolumab (Opdivo):** - \*
- **Pembrolizumab (Keytruda):** - 0
- **Other active systemic anti-cancer therapy:** 0
- **Palliative care only:** We do not hold this information due to the vast number of ways patient can be referred to palliative care services, some of which bypass University Hospitals Bristol and Weston NHS Foundation Trust entirely.

**Q3. Does your trust participate in any ongoing clinical trials for the treatment of urothelial cancer? If so, can you please provide the name of each trial along with the number of patients taking part?**

Raider (closed to recruitment now in follow up): 12 recruited.

Atlantis (closed to recruitment now in follow up): 8 recruited.

**Q4. How many early-stage (non-metastatic or Stages 1-3) non-small cell lung cancer (NSCLC) patients were treated in the past 3 months with: Our SACT e-prescribing system records metastatic status but not stages 1-3. All patients reported below have no metastases.**

- **Atezolizumab (Tecentriq):** - \*
- **Durvalumab (Imfinzi):** - 6
- **Nivolumab (Opdivo):** - \*
- **Pembrolizumab (Keytruda):** - 25
- **Chemotherapy:** - 11
- **Radiotherapy:** - 20 patients treated for lung cancer (the radiotherapy system does not record what type)
- **Chemotherapy AND Radiotherapy:** - \*

Please note: Where the figures are between 1 and 5, this has been denoted by \*. Due to the low numbers, we have considered that there is the potential for individuals to be identified from the information provided, when considered with other information that may also be in the public domain. In our view disclosure of these low figures would breach one of the Data Protection Principles set out in Schedule 1 of the Data Protection Act, namely Principle 1. The Trust therefore finds that the Section 40(2) exemption contained within the Freedom of information Act 2000 is engaged. This follows NHS Digital (formerly HSCIC) analysis guidance (2014) which states that small numbers within local authorities, wards, postcode districts, providers and Trusts may allow identification of patients and should not be published.
