Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

- We can confirm that we hold some of the information you are requesting
- 1. Please can you confirm whether the trust runs a Complication of Excess Weight Clinic?

Yes - for paediatrics.

- 2. Please tell me how many patients in the trust are currently being prescribed semaglutide for weight management in the following age categories:
- **a) Aged 12 or under** 0
- **b) Aged 13 to 17** 15

(Please also confirm whether this was through the CEW clinic – if the trust has answered yes to question 1) - Yes

3. Please tell me the age of the youngest patient currently being prescribed semaglutide for weight management

We have not provided the information in the requested format as we have considered that there is the potential for the individuals to be identified, when considered with other information that may be in the public domain. In our view disclosure of information would breach the Data Protection Act. Therefore please find that Section 40 (2) exemption contained within the Freedom of Information Act 2000 is engaged. Section 40 is the exemption for personal information.

- 4. Please tell me how many patients a) aged 12 and under and b) aged 13 to 17 have been prescribed semaglutide for weight management in the following years
- a) 2024 *
- **b) 2023** Approximately 12
- c) 2022 Not known we do not hold this information

5. If the trust has not issued any prescriptions semaglutide for weight management in patients under 18, please tell me if there are any plans to do so in the near future? Not applicable.
