Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

We can confirm that we do hold the information you are requesting

1. Does your hospital have a PICU outreach service?

We have a Paediatric Critical Care Outreach service but is not linked to PICU, it's a separate team.

o If so, how many staff per shift work within this service, and what are their grades? We have Band 7s and Band 6's within the Outreach team. On average we have 1 Outreach nurse on a LD, 1 on a Twilight and 1 on a Night shift.

2. How do you measure the effectiveness of this service?

As the team has been established for over 10 years, we do not routinely collect data. We use staff feedback, Datix, Greatix, complaints to review effectiveness and amend our medical model has needed.

o Could you share the benefits you have identified?

We do not hold this information.

o Do you have any relevant statistics, such as reductions in admission or readmission rates to PICU?

We are currently completing an audit looking at unplanned admissions to PICU for 2024, the results have not been collated to date.

3. If your hospital does not have a PICU outreach service, how is the deteriorating child supported?

Not applicable

o Do you use PEWS scoring, a watcher list, or rapid response teams?

We use electronic PEWs and we have a rapid review team alongside our Outreach team.

o Can you provide any statistics related to PICU admissions (for the past three years) or readmissions from ward areas? (within 48 hours in the last 12 months)
