Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

We can confirm that we do hold the information you are requesting

# 1. How many doses of each of the following strengths of Meropenem do you administer annually?

- 500mg
- 1 gram
- 2 grams

The figures in the table below represent the number of **vials** used, rather than the number of doses administered. The data is taken from Refine as electronic prescribing is not yet in use across the trust. Both 2023 and 2024 (to end of November 2024) are included, plus the mean of the (almost) 2 calendar years.

### 2. What are the main areas of your hospital where Meropenem is used?

- GICU/cardiac ICU
- Medicine
- Children's hospital (especially haematology/oncology, PICU)
- Adult haematology/oncology

### 3. What are the main conditions you use Meropenem to treat?

Meropenem is recommended for a very limited number of indications in our guidance, but is more commonly used for:

- On microbiology advice, sepsis etc. in GICU/CICU.
- 2nd or 3rd line for neutropenic sepsis
- PICU/paediatric haematology/oncology

Cystic fibrosis patients

# 4. How do you currently administer Meropenem via bolus or infusion? If you infuse, do you use gravity or pump sets?

We use a bolus on most general wards but for new prescriptions in ICUs (general, cardiac and Weston General ICU), a 5 min bolus is administered stat, followed by a 3-hour extended infusion via pumps.

- 5. Where is your Meropenem currently reconstituted (e.g., wards or aseptic units)? Currently reconstituted on wards
- **6.** Do you face any challenges when administering Meropenem? Not currently aware of any.
- 7. Do you frequently experience drug shortages of Meropenem?

# 8. How many medication errors do you experience per month when administering Meropenem?

In the past year, there have been seven incidents involving meropenem due to a variety of reasons (incorrect frequency, non-availability of drug, etc.)
